**Associate Level New Membership Application Waiver Form**

**Form of Indemnification, Waiver, and Release Agreement for all  
Activities Performed at the San Jose Municipal Firing Range**

All SCVRC Members, guests, visitors, attendees, or any other users of the San Jose Municipal Firing Range shall execute the following agreement providing for the waiver and release of liability, and indemnification of, CITY and OPERATOR, in the following form:

I (*legibly print name here*) \_\_\_\_\_ hereby understand and agree to accept the risk of bodily injury and/or property damage which I may incur or cause a third party to incur as a result of my use of the Rifle Range facilities and premises. I understand that this risk includes, but is not limited to, any lead dust inhalation, noise, airborne materials or objects, and the actions of other users of the Rifle Range. With this understanding, I further agree to indemnify, defend, and hold harmless the City of San Jose, its officers, agents, and employees, and the OPERATOR, its officers, agents, volunteers, and employees, from and against any and all claims, leases, injuries, suits or judgments arising from, or in connection with, my/our presence on the Rifle Range. I agree to this indemnification and save harmless for myself, my successors, assigns, heirs, executors and administrators, and any other person or entity(ies) who/which may have a claim based upon my personal injuries and/or property damage.

I have read and agree to abide by the rules and regulations pertaining to use of the Rifle Range and acknowledge receipt of a copy of same. I understand further that I will be held financially responsible for any damage to facilities or equipment which occurs through my use of the Rifle Range.

Furthermore, I acknowledge that each of the following is true:

- 1) I have not been convicted of a felony under the laws of the United States, the State of California, or any other state, government, or country;
  - 2) I am not addicted to any narcotic drugs;
  - 3) I am not subject to a temporary restraining order issued pursuant to section 527.6 or 527.8 of the Civil Code for harassing behavior;
  - 4) I have not been convicted of a misdemeanor violation that prohibits owning, possessing or having under my custody or control any firearm within 10 years of the conviction;
- and therefore I may legally possess a firearm or ammunition as defined by California Law (CA Penal Code § 12021(a-g); CA Penal Code § 12316(b)).
